As you can observe, there is dampness due to water seepage & other climate conditions. This provides good conditions for white ants/termites, etc. During one of the inspection, it is noticed that records has been totally destroyed by white ants. After noticing this immediately anti termites treatment was undertaken to prevent further damage.
