Res. No. 5 (7):- Upon question by the Gram Sabha members regarding Token House Number. The Sarpanch V.P. informed that the code of conduct is in force, hence no decision to be adopted, but expressed fear that the Government notification on token house number to illegal structures will lead to sprouting of more illegal houses & called for revamping the guidelines to the notifications.

The basic aim of the notifications was to give token house number to illegal houses which already exists for mote than 20 years so that the Panchayat could get revenue. But now taking advantages of the notifications, people have started building houses on orchard land & in paddy field & then apply for token house number.

These people simultaneously apply under Health Act & obtain N.O.C. for water & electric connections. Sarpanch further informed that there are 30 applications for token house number pending with the Panchayat. Matter was discussed at length.
