**Res. No. 3 (1):-** Application received from Dayanand Bhonsle was placed before the Gram Sabha meeting. The Sarpanch narrated the hardship faced by the Kashmir Hindus since 1990. These people are living life of refugees in their own country in the tents. After detail discussion it was resolved to send communication to the Central Government requesting to take necessary steps for re-habilitation of Kashmir Hindus at the earliest.

3 (2): **Display of banners/hoarding in V.P. jurisdiction.**

**Res. No. 3 (2):-** Application received from Ajit S. Porob, r/o Palmar, Pomburpa regd. display of banners in Panchayat jurisdiction has been discussed.

The Gram Sabha members expressed disappointment on the rise of members of unauthorized banners/hoarding in the village. Some members questioned the Panchayat whether permission was sought for the display of the banners & whether appropriate fees were paid to erect the banners/hoardings.

One of the Gram Sabha meeting it was passed a resolution that every ward member would be responsible to oversee the hoisting of the banners & any un-authorized banners be removed promptly by the particular ward member.

The Sarpanch has informed that registered letters was sent to all the people who had displayed the banners as accession of Ganesh Chaturthi without permission.

The reply received & details of fees paid/unpaid were placed before the Gram Sabha, read out, discussed for decision. After detail discussion it was proposed by the Gram Sabha members that letters be sent to all the defaulters & cost of removing banners be recovered from all such people.

Resolution passed unanimously.

Further the Sarpanch informed that vide memorandum No. 19/DP/Hoarding/2016/6554 dated 28/16/2016 received from Dy. D.O.P. Panaji regd. removal of hoarding in V.P. without the permission of V.P. immediately be removed.

4) **Discussion on Revenue jurisdiction, postal & police jurisdiction for the wards of Velotim & Ecoxim:**

**Res. No. 4:-** Application received from villagers of Ecoxim regarding revenue jurisdiction has been read out, discussed for decision.

The village of Olaulim upto the Mother of God Church Pomburpa comes under the Carona Post Office & Mapusa Police station jurisdiction.

From Mother of God Church upto Ecoxim comes under Betim Post Office & Porvorim Police Station & Salvador-do-Mundo (Revenue village). Villagers face lot of hardship in trying to locate which police station or post office they come under. Whenever a person from Ecoxim rushes to Mapusa Police Station with a complaint he is directed to approach the Porvorim Police Station & vice versa.

Their EPIC address has shown as Ecoxim Salvador-do-Mundo & when these people apply for passport are put to untold hardship due to jurisdiction of the village divided between two post offices & 2 police stations. After detail discussion it is unanimously decided & resolved by the Gram Sabha members to request the State Government to bring the entire village under one post office & one police station.

It was further resolved to undertake re-survey of the area from Velotim upto Chodanwaddo in Ecoxim & request for separate revenue jurisdiction in the name of "Ecoxim" village.

Resolution passed unanimously.

5) Deletion of house tax records of the non-existing houses.

**Res. No. 5:-** Discussion took place on deletion of house tax records of the non-existing houses/that have not paid house taxes dues for many years i.e. house is in dilapidated condition or it is locked as the house owners are not traceable. After elaborate discussion, the Gram Sabha members resolved to display notice in the public places. If response is not received within reasonable period, Panchayat body to take appropriate decision.
